## 2010 OPENING DAY SCRAMBLE

The 2010 SPGA Opening Day Scramble will be on **Thursday, April 15th**, at the **North Shore** Golf Course, 4101 North Shore Blvd. NE, Tacoma, WA. The cost of the tournament will be **\$60.00** per player. This amount includes your round of golf, half golf cart (not an option), the prize fund and pro shop tariff and tax. The first tee time will be 0830 hours.

This Spring Opener will be played like last year, there will be **three divisions**. You may **pick your own team** and enter as a foursome or you may **enter as a single, twosome or threesome** and the committee will fill in your team. Remember, in past years, very low total handicap teams faired poorly when giving strokes to teams with higher handicaps, so choose your teams wisely. Also, you can invite a friend to play in your foursome for a nominal surcharge. **Three drives and four second shots** will be **required** from each team member again. All players are eligible to play every shot.

The top three teams, in each division will be in the money. In the event of ties, the team score cards will be compared, beginning at the **number one handicap hole** and continuing through the holes in **handicap order** until a lower score prevails. Four KP competitions will be divided by handicap (below 20 and 20.0 and above). Winners will be paid by mail.

Once the deadline for entries has expired, you will receive your team and tee time notifications along with specific rules for play. Every effort will be made to accommodate tee time and ride sharing requests.
